The owner of a 0.75-acre lot located at 2115 Arnold Way and Olivewood Lane in Alpine has applied for a discretionary permit for a site plan exemption to develop a 13-unit townhome project (PDS2018-STP-18-030). The lot is zoned Village Core Mixed Use. Water service shall be provided by Padre Dam and the project will connect to sewer. NOTICE – The county of San Diego has noticed the group that this project does not require a recommendation from the ACPG. All public feedback will be directed to Alpine Design Review Board and the County of San Diego PDS. **Information Item Only.**

2. The owner of a 25.66-acre parcel located at 7177 Horsethief Canyon Road, Alpine, CA 91901 has applied for a discretionary permit for agricultural clearing (PDS2018-AD-18-023). The application requests to clear existing vegetation in order to allow for agricultural planting.
