This roundabout needs to be established for the Bonsall Elementary school children as well as the 400 new homes plus, all the school traffic and residents using this intersection as currently designed it is very dangerous.

- d. Three items mentioned at our April meeting have been moved forward and action is being taken report will be available at June meeting.
  - (1). Park & Ride East Vista Way and Highway 76. (2.) Trucks using Gopher Canyon Road are exceeding the posted 7-ton weight limit. The County has called for more coverage from the Highway Patrol and recommends residents call the office of California Highway Patrol 760-643-3400 if they see an increase in truck traffic. (3) Parking on Camino del Rey.
