A request has been made for a "Community Planning or Sponsor Group Project Recommendation" regarding the Friends of Willow Tree project located at 6893 W. Lilac Rd. in Bonsall, California 92003. APN#'s 127-541-05 and 127-350-02. According to the Notice to Property Owners, the project involves the development and construction of the Willow Tree Enrichment Center. The building includes transitional Kindergarten/Kindergarten through Eighth Grade, with a maximum of 216 students. It is comprised of nine buildings totaling 41,328 gross square feet on 6.41 acres. The zoning is Rual Residential (RR) with a General Plan of Semi-Rural Residential (SR-4).
