
Miguel Angel Bautista submitted a Discretionary Permit Application and a Minor Use Permit to the County of San Diego on June 13, 2023. The applicant would like to subdivide a 14.625-acre vacant lot to generate three residential lots with a minimum of 4.0 acres for each lot. The project is located at located at 1650 Vista Del Mar in Vista, California, near Little Gopher Canyon Road. All three lots would be adjacent to Vista Del Mar, and each lot would have its own driveway.

San Diego County has requested a Community Planning Group Project Review and a Design Review Board Project Review. A parcel map, fire/water/sewer forms, and an application for an environmental initial study (AEIS) were submitted.
