Discussion occurred. Haider mentioned that community members who live in The Havens Country Club area (also known as Vista Valley Country Club) are concerned about the traffic on Gopher Canyon Rd., Little Gopher Canyon Rd., Vista Valley Dr., and Fairview Dr. They would like Norris, BCSG Chair, to present their concerns and requests to Supervisor Desmond. Norris agreed.

More discussion occurred regarding infrastructure problems throughout Bonsall. BUSD Superintendent Clevenger stated concern about kids' safety because the roads are all inter-connected.

Further discussion occurred, and the BCSG decided to also include information about Bonsall Community Park and the San Diego Association of Governments (SANDAG) funds in the presentation.
