

- a. PDS2014-AD-14-002 Stonewood Properties Administrative Permit
County staff will be in attendance to answer questions regarding the information letter sent by staff dated January 7, 2015 regarding the residence located at 4438 Via De Los Cepillos.
- b. PDS2014-MUP-14-024 Champagne Lakes Wireless Facility: This project has been continued for several months but is now ready for review. Project is sited on a nursery located off of Aqueduct.
- c. PDS2014-AD-14—64 Solterra Vineyards this project is an application to clear 12 acres of primarily dried grasses and a small percentage of shrubs from property to plant a vineyard.
