- E. ACTION ITEMS: (Voting Items)
 - a. On April 1, 2015 the Governor issued an Executive Order pertaining to the existing drought conditions facing California. As part of the Executive Order a number of State requirements were created to address and mitigate the on-going emergency drought condition. One of the requirements directed the State's Department of Water Resources (DWR) to amend their MWELo. The County is now required to adopt the State's amended MWELo or adopt a County ordinance as effective as the State's ordinance at conserving water. Generally the amended MWELo has broader project applicability (requires more projects to submit for landscape plan review) and provides for greater restrictions associated with landscaping water. **This item will be returning at a later date for our final vote recommendations are requested now.**
