- A. CALL TO ORDER/ROLL CALL** – Order was called by Chair Falk at 4:30 p.m. – Members Present were; Chair Rebecca Falk, Vice Chair Clint Brandin, Secretary David Farley, Bonnie Petrach, Bill Haneline, Linda Haddock. Members absent were - Judy Haldeman.
- B. APPROVAL OF THE MINUTES FOR THE MEETING OF July 5, 2018** – Motion to approve the minutes from the July 5, 2018 meeting was made by Linda Haddock and seconded by VC Clint Brandin. Discussion was made and Linda moved to amend the minutes. Vice Chair Brandin seconded. All members voting “Aye” to approve the minutes as amended.
