**1. Downtown Sidewalk Improvements Project--one change in the project the Sponsor Group voted to recommend at the April 1 meeting.** Fire Chief Hardcastle asked that the speed tables (3" flat topped bumps) not be part of the project since they slow down emergency vehicles. This is an opportunity to discuss if there is any issue with simply removing the two speed tables from the project. Presentation by Sambath Chrun, San Diego County Dept of Public Works Project Manager.

**2. Creation of three standing subcommittees of the Sponsor Group.** The SG Chair will recommend the formation of three standing committees and nominations of SG members and members of the public to serve on those committees. The vote will seek concurrence of the Sponsor Group for these committees: Water and Land Use/Planning, County Programs and Regulations, and Road Maintenance.
