D. ACTION ITEMS:

1. The San Diego County Department of Public Works (DPW), Capital Improvement Program, requests our participation in identifying a prioritized list of transportation improvement projects on the county-maintained road network in Borrego Springs. See agenda packet for the request and for recommendations carried over from previous years with slight modifications from the Revitalization Committee. Ryan Lau, CIP, DPW will be present to answer questions. Discussion and vote to approve or amend recommendations.

2. As recommended by the County Programs/Regulations Committee: Presentation and Request for Community Input on County Climate Action Plan Update, Smart Growth Alternatives. Kelly Bray, Chief, Sustainability, PDS and Darin Neufeld, Harris & Associates, Environmental Planning and Compliance. Please review slide show at agenda packet link at the top of this agenda. The SG can make formal or informal recommendations about incentives and disincentives for growth within targeted areas in town.

3. The Water and Land Use Subcommittee (WATCO) has referred two letters they have written to the Sponsor Group for approval to send out jointly from the Sponsor Group and WATCO. 1. Update County BOS vote on Jacumba JVR Solar Project: BOS voted in August to approve the solar project with the conditions that the company negotiate with the town for an increase from a 300'

setback to a 400'-1000' setback or cushion and also provide \$4 million to community improvements, to be negotiated with the town, instead of \$1.6 million.
