Pursuant to Government Code section 54953(e)(3), a motion to find the legislative body has reconsidered the circumstances of the State of Emergency and state and local officials continue to recommend measures to promote social distancing.
 - 3. La Casa Del Zoro Solar Project Fencing Beautification, first check-in since project approval. John Wells will present for La Casa, and Judy Haldeman and Nancy McRae may also report with their conversations with La Casa about this. No action anticipated at this time, but possible.
