### Attachment A: The following was received by Watco Member Diane Johnson on November 6, 2023:

Hello Watco. I propose an item for the Agenda, not sure if it's action or discussion.

I have heard some comments, re the TAC, that it looks like the Recreation and Ag members are most focussed on slowing down water usage and the decline of water in storage — and both are already addressed by the Rampdown agreed to in the Judgment. They therefore might have little interest in water quality (WQ) issues here, especially since these consultants are also very involved in serious SGMA issues (like severe subsidence) in other bigger basins (like Kern).

From attending many WMB meetings, I have an impression that some members regard ensuring decent WQ as only a BWD issue. That's not true — SGMA makes it a GSA/WMB issue, by naming it as an Undesirable Result which must be addressed in order to attain a Sustainable Yield for the basin, as SGMA requires by 2040. And then of course there's the equity concern (which has become an underlying principle of California water law and regulations): the excess nitrates that are showing up at some wells come from ag chemicals — and those wells are in the ag area in the north of the Valley. Which is also, of course, the biggest, most productive area in our basin. Digging a new, deeper production well — which is a possible Management Action proposed in the Draft GMP (see attached file with the WQ sections of that document) — last year cost BMA about \$1.5 million, and that was before the recent inflation in materials costs. That's a lot of money for our small utility with not many ratepayers, in our largely economically disadvantaged community.

I think this means that the more community-oriented TAC and WMB members (representing BWD, the community, and yes the County) need to work extra hard to make sure that <u>protecting WQ</u> is not forgotten by the WMB as we implement the Judgment and SGMA.

>>> I wish to propose that Watco needs to support them. Decline of WQ is an Undesirable Result in SGMA — and, even more importantly, Borrego needs to be able to count on an adequate potable water supply for the future.

FYI, BWD's Tech Consultant, Trey Driscoll, just last month drafted a very exhaustive and useful study of WQ here, down to the level of individual wells in some cases. I'm including a link to it. If this doesn't work please let me know and I can get you the draft memo some other way. It's 15 meg, because of the many graphics. The full PDF version with all figures is located as follows:

THE UNDERLYING STRATEGY THAT MUST BE KEPT IN MIND IS TO MAKE SURE THAT THERE IS ENOUGH MONEY ALLOCATED IN BOTH THE WMB AND TAC BUDGETS TO KEEP DOING THIS WORK. AND TO ENSURE THAT THE TOPIC GETS ON WMB AGENDAS REGULARLY.

To my thinking, there are at least 4 parts to ensuring good water quality here.

- 1. monitor WQ. Make sure there's enough money in the budget for West Yost to both do the monitoring and analyze the results on a timely basis.
- 2. set cautious Minimum Thresholds for contaminants ones that don't let them get to the regulatory Maximum Containment Level (MCL) before analyzing and planning what needs to be done to preserve good WQ, Again, make sure there's enough money in the West Yost budgets for both the WMB and the TAC.
- 3. determine a Project and Management Action. Again, make sure there's enough money in the West Yost budgets for both the WMB and the TAC.
- 4. begin implementing the PMA. If it has been decided that a new municipal (BWD) well is needed, this will almost certainly involve seeking to obtain grants to assist in paying for it. And, budgets ...

Thanks for taking the time to read this. I know it's long — but the issues we face are both complex and very important!
