The room was very divided on this topic, with comments against the license, based on existing over-availability of alcohol in the immediate neighborhood, as well as homes and a church nearby. Comments in favor focused on making local beer pricing more competitive for our generally low income population.

Wellman Simmonds made a motion to deny the license and Kieth Crowl seconded. The motion failed 2, 2, 0, with Steve Biddle and Rob Romero opposed.
