a. San Diego County Office of the Sheriff will discuss it's policy on placing cameras in selected areas to help deter crime. Questions from the public will be welcome. Lt. Jeff Ford of the Sheriff's Rural Command to present. Discussion only.

- Lt Ford passes out literature regarding automated license plate readers and explains how they are strategically placed to target areas in order to assist with crime prevention
- Rob: As time goes on will there be additional cameras?
- Lt Ford: There very well could be but we don't know at this point
- Nick: What is the approximate cost per unit?
- Lt Ford: It will cost us nothing
- Nick: How do we agree to this but put limitations to power
- Lt Ford: There are current laws that don't allow items like speed traps
- Cory: This could potentially be a new version of the patriot act but that being said, can you explain how well this system works?
- LT Ford: I had more vehicle recoveries by utilizing this system when Escondido implemented the FLOCK system
- Al: Will these be installed on Sheriff vehicles?
- Lt Ford: They can be and they are detachable so they can be used in different Sheriff vehicles
- Larry: If a piece of data comes in and you want to save it beyond 30 days, what level does someone have to be in order to save the information?
- Lt Ford: Any detective
- Steve: Are the cameras stationary or are they portable?
- Lt Ford: The ones I have requested out here will be stationary
- Nick: Is the information secure or is it public information?
- Lt Ford: The information is not public information
