a. National Monument Proposal, Kathleen Beck Presentation

Presentation by Dave Hogan of the Chaparral Lands Conservancy (CLC). CLC is proposing a National Monument designation for Cleveland National Forest and BLM lands.

National Monument designation would be established by Presidential decree under the 1906 Antiquities Act. Approximately 480 thousand acres; 85% of CNF lands in San Diego and a portion in Riverside County. Hogan did not have any mapping with him but said maps are available for the affected lands. Goals of the Monument would be access, recreation, Indian tribal input, watershed protection and additional staffing.

Group had concerns on the lack of any written proposals, fire/vegetation management, public access, government management (who is going to be in charge).

Hogan said he had support from the Boulevard Planning Group and Julian Chamber of Commerce. He will provide more information to the group as it becomes available.
