    - a. Representatives of San Diego Gas and Electric to provide project update undergrounding power lines

As part of SDGE Wildfire Mitigation Plan (WMP), SDGE is implementing a Strategic Undergrounding Program for Descanso. There already is a direct underground system from the substation to Elementary, Library, Perkins, Cal fire and Town Hall. Their newest plan is to underground the power lines (circuit 73) from substation down Oak Grove, Viejas Grade, Oak Grove/Manzanita Dr, Riverside Drive, Highway 79 to Interstate 8. All customers will have their power feeds undergrounded to their meters. Goal is to also underground the ATT communication lines, but all details have not been worked out. The direct line to Perkins has additional conduits to accommodate these utilities. 3 stage project; Civil work, Wire pulling and Removal of old lines. No construction forecast is available at this time but are shooting for 2023. Community questions includes concerns over the Wood to Steel project and it's visual impacts on the community, accommodating a pedestrian walkway on Riverside Bridge, weatherhead to weatherhead connections, leaving the old wood poles with communication lines, impacts to community from construction and power conversions at time of construction. SDGE will keep us informed of any changes and updates.
