A. 3 Sisters Water Fall, Pending Actions by Cleveland National Forest

Lee Hamm Recreation Officer, USFS, Palomar District gave presentation on the Three Sisters Waterfalls located out Boulder Creek Road. There has been a large increase in visitors to this site. 300 to 400 cars on weekends. Numerous emergency calls, no restrooms, no trash, no designated trails, vehicles blocking road, trail is difficult and dangerous. Forest Service has developed a use plan for this area with different alternatives including doing nothing, closing site, developing a trail system, parking area and restrooms (alt 2).

Group discussed situation and options.

Motion: Forrest/Gibson Support alternative 2 with safety modifications including utilizing the existing road system to allow emergency vehicles to access an area closer to the falls. 7-0-0
