County had approved the original TPM in 2010 and the site plan in 2015. There are no proposed changes to the TPM or Site Plan. There have been changes in the storm water laws since original approval. Property owner still needs to complete road and site improvements per the TPM and site plan. Owner Shellstrom is asking DPG approval of the time extension to give her time to complete same. Time expires in December.

Group Discussion:

DPG opposed original TPM because project did not meet new community plan density and Community Character standards. This area is noted for its high groundwater issues and view shed sensitivities. Chair (and others) voiced their concerns on the projects impacts to ground water, view sheds and new community plan standards and voiced their desires to oppose the time extension and to let this project's map expire and have the property revert to the new zoning/density.

Motion: To not recommend the time extension as project does not meet current community density and character standards. White/Millner 5-1-0-1 Elliott oppose.
