1. Call to order.
The meeting was called to order by Acting Chair Kim Murphy at 5:33 PM. Acting Chair Murphy was asked to chair the meeting in Chair Delaney's absence.
2. **PUBLIC FORUM.** Opportunity for members of the public to speak to the Ad-hoc Cannabis Ordinance Committee on any subject matter within the Committee's jurisdiction but not on today's agenda. *Three-minute limitation. Non-discussion and nonvoting item.*
No public comment was offered.
3. Approval of previous meeting minutes. **Voting item.**
Motion by Brown to approve minutes as corrected with removing the transcript style. Motion passes. 7-0.
4. Continuing discussion and update on the social equity portion of the County Cannabis Ordinance. Discussion and recommendations on zoning. Discussion and recommendations on local input and control. Discussion and recommendations on other cannabis-related board directives and recommendations. County Planner: Donald Chase (donald.chase@sdcounty.ca.gov). **Ad-hoc Cannabis Ordinance Committee. Community Input. Voting Item.**
 - Acting Chair Murphy announced that the social equity portion of the new Cannabis Ordinance has been removed from the purview of the Planning Groups and will no longer be discussed.
 - Discussion was held on setbacks from sensitive areas, the timeline required to make recommendations that hold weight with the County, holding an extra meeting in either July or August, and what topics should be addressed. The committee requested that if a field trip were not possible, it would be preferable to have an industry representative(s) present at the next meeting to speak to concerns of the committee members.
 - Committee members requested that County staff be present at the next meeting to answer questions by the committee members and to provide an update on the process of the ordinance as well as to clarify what the committee is being asked to deliberate upon.
 - Public comments were offered by Pedro Cardenas, April Schminke, Terra Arwood, and Nicole Smith. Discussion was held in an open forum format that welcomed community input throughout the discussion process.
 - No motions were made.
