# 7. REVIEW AND DISCUSSION ON THE CANNABIS PROGRAM DRAFT EIR. County Planner, Jessica Norton, <u>Jessica.norton@sdcounty.ca.gov</u> Cannabis Ad-Hoc Committee. Community input. Non-voting

- NOTE: Agenda item is limited discussion for the draft EIR only
- Background information on proposed Cannabis Program: SD County BOS directed staff to proceed with the Cannabis
- Jessica Norton clarified this program is directed is only unincorporated areas of the county only
  - o Excludes: Federal, state, county public land, tribal lands, any land preserved
- ➤ Below are the questions sent to Jessica Norton in advance of the meeting by Jeniene Domercq, chair Cannabis Ad-Hoc Committee
- > How many total acres for cultivation will be allowed in each unincorporated area?
  - o Depends on what alternative is adopted by the BOS
- ➤ It is our understanding that 25 dispensaries will be allowed throughout the unincorporated areas
  - There are 5 locations currently, this EIR would include up to 20 additional licenses
- ➤ How will this be divided into each community?
  - o Location requirements will be defined by the option adopted by the BOS
- Regarding the Oversight Committee:
  - o Is part of the social equity program
  - o At the time of the meeting the community collaborative had not been formed
- ➤ How many consumption lounges will be allowed in each community?
  - o Consumption lounges are limited to licensed dispensaries
- ➤ The data for the DEIR is years old. It does not appear to be based on current environmental impacts that communities in California with Cannabis Programs are experiencing. Will the county be revising the DEIR to reflect more up to date studies and impacts?

- The purpose of this review period is for input of circumstances that may have changed the have environmental impacts that did not exist at the time of the initial study. If there are studies that so raise concerns, please be very specific and any issue communicated to the county.
- O Please provide references to the study and/or links
- The county is legally required to respond to all comments made during the review period.
- ➤ Outdoor Grows have been documented as causing major impacts in other Communities with Cannabis Programs. With this knowledge, why is the County recommending Alternative #2 for the Program which allows outdoor grows in A70 and A72 knowing that these zones are adjacent to residential zones?
  - SD county staff is not recommending any alternative. The BOS will determine what alternative is adopted
- Cultivation issues such as odor have been nearly impossible to enforce in other areas with Cannabis Programs. As an example Santa Barbara and Carpentaria have had 4,000 odor complaints. Of those complaints not a single one was enforced. At times children in these communities were not able to play outdoors during recess at school because of odors. Residents were unable to enjoy outside activities. How will the County's Program handle this and ensure that this doesn't happen to our children and residents?
  - The proposed code requires site odor mitigation plan (attachment B and D of the EIR)
  - o Quarterly inspections are proposed
  - o EIR alternatives 4 and 5 will present the lowest odor impact
- ➤ How will our Program mitigate environmental concerns such as groundwater contamination, soil contamination, damage to private roads, lights and noise?
  - o Draft EIR addresses all environmental concerns
- ➤ How will existing wineries be protected from negative impacts of Cannabis grows and cultivation in their crops?
  - O Section 2.3 of the EIR evaluates potential impact
  - O Jeniene Domercq noted the in Santa Barbara wineries have said they have noticed the tast3 of the wine has changed
    - The county has not heard about this issue. Requested if there are any studies showing the change in taste in any agricultural crops due to cannabis, please submit to them for review
- > Our unincorporated communities have many private roads in areas that are in AG and residential zones. Residents who live on these roads are responsible for the cost of maintaining these roads. How will the potential for damage to these roads be mitigated with the residents being liable for the cost of the repairs?
  - SD County does have private road standards that provide the minimum requirements for road improvements for new developments that are conditions of land development projects.

    - SD County From the center line of the property
  - Community member Are separate permits required for processing enforcing odor mitigation
    - SD County states it is not required due to rule 51
