- Two potential zoning ordinance updates: (1) allow for amplified live music at boutique wineries and (2) extend the maximum permitting time for healthcare trailers.
- Detailed Discussion & Public Comments on Boutique Wineries Amplified Music:
 - o Noise Ordinance Compliance: Proposed regulations and use of noise studies.
 - Maximum Occupancy: Discussion of square footage, occupancy limits, and regulations around outdoor seating.
 - o Events and Ticketing: Clarifications on advertising, events, and ticketing.
 - Elise Moreno (San Diego County Vintner Association): Commented on the importance of events for boutique wineries and requested clarification on hosting community events, grandfathering existing wineries, and outdoor seating.
 - Public Speaker: Expressed concerns about the amendment allowing amplified music at boutique wineries for 365 days a year and noise issues affecting residents.
 - o Melinda Romine (Myrtle Creek Winery): Advocated for small wineries, emphasizing community benefits, and job creation.
 - O Sister of Melinda Romine: Expressed that indoor amplified music still affects noise and residents 2500 feet away and are negatively affected.
 - Lila Hargrove (Fallbrook Chamber of Commerce): Highlighted wineries as
 economic anchors, emphasized the need for enforcement on existing violations
 rather than new restrictions.
 - O Vicki Merrick (Adobe Hill Winery): Stressed the need to differentiate regulations between boutique and commercial wineries.
