- 9. Minor Deviation for a generator at Crestwood Behavioral Health, 624 E. Elder. Contact: Mike Cantelmi, <u>mike@legfresno.com</u> County Planner: Chris Zermeno chris.zermeno@sdcounty.ca.gov **Design Review Board Committee**. Public comments. Voting.
  - Ryan De La Cruz from Endurant Energy presented a proposal for installing a linear generator at Crestwood's facility on Elder Street. The generator would convert natural gas to electricity through a chemical process rather than combustion.
    - o Key points about the generator:
      - Operates 24/7 to provide cost savings and budget certainty over 20 years
      - Can also operate during power outages as a backup power source
      - Produces about 70 decibels of sound at 10 feet (comparable to a busy restaurant)
      - Sound would be attenuated by an 8-foot fence with privacy slats and vegetation
      - The technology has been in commercial use for about 10 years
      - There are approximately 50 installations in the US, with 10-12 in Southern California
      - They operate based on the principle of electromagnetic induction, similar to traditional rotary generators but without the need for a crankshaft.
  - Community concerns addressed:
    - o Sound levels and mitigation measures
    - Safety features including emergency shutoff valves
    - Visual impact and screening
    - Emissions and environmental impact

- 10. Urgent request to DPW for the installation of a signal on Fallbrook Street by the new Village View Park. Flashing crosswalk lights are being ignored by drivers and the glare from the sun at

certain times of the day makes it very difficult for drivers to see pedestrians crossing Fallbrook Street. **Circulation Committee.** Public comments. Voting item.

- The group discussed serious safety concerns regarding the crosswalk at the new Village View Park on Fallbrook Street.
- Safety issues identified:
  - o Current flashing lights at the crosswalk are being ignored by drivers
  - o Cars traveling at approximately 40 mph on Fallbrook Street
  - o Poor visibility at the crosswalk due to sun glare and line of sight problems
  - o Reports of near-misses with pedestrians
- Community input:
  - o Dan Escimozza: "Cars travel on Fallbrook Street at 40 miles per hour and the crosswalks are not easily visible when approaching."
  - O Jack Schernes: Suggested immediately lowering the speed limit to 25 or 15 mph until a traffic light is installed
  - Jillian: Asked about the possibility of a HAWK signal instead of a full traffic light

The group unanimously approved sending an urgent letter to the Department of Public Works requesting safety improvements at the crosswalk. The letter will ask the county to address safety issues caused by sun glare, line of sight problems, and speed.

# 11. Update on BESS (Battery Energy Storage System) **Public Facilities Committee**. Public comments. Non Voting.

- Jeniene Domercq provided an update on communications with SDG&E regarding battery energy storage systems.
  - Current status:
    - o A letter was sent to SDG&E requesting a site visit and town hall meeting
    - o SDG&E acknowledged receipt of the email but has not yet responded substantively
    - o The group will follow up with SDG&E this week
    - o When a town hall is planned, elected officials will also be invited
- 12. PDS2025-TM5664 "The Arbors" residential project at the old Nickerson's Nursery at the corner of Stagecoach Lane/Gumtree/E. Mission Road across from William Frazier Elementary School. Proposed project will be a total of 48 dwelling units which includes 3 low income units, using density bonus laws for waivers and incentives Contact: Sean Kilkenney, Nolen Communities, <a href="mailto:skilkenny@nolencommunities.com">skilkenny@nolencommunities.com</a> County Planner: Bronwynn Brown, <a href="mailto:brown@sdcounty.ca.gov">bronwynn.brown@sdcounty.ca.gov</a> Land Use Committee and Design Review Board Committee. Public Comments. Voting item.
  - Sean Kilkenny from Nolen Communities presented a proposed 36-unit housing development on the former Nickerson's Nursery property. The project would use state density bonus law to increase the number of units beyond what base zoning would allow.
    - Project details:
      - 12.87 acres located at the intersection of Gumtree Lane, North Stagecoach, and East Mission Road

- o Adjacent to William H. Frazier Elementary School
- o 36 lots proposed (33 market-rate and 3 income-restricted units)
- O Base zoning would allow 26 units; density bonus allows 10 additional units
- o Includes 3 private park areas including a dog park
- Single point of access from Gumtree Lane
- Requested waivers and incentives:
  - o Minimum lot size reduction from 20,000 sq ft to approximately 4,800 sq ft
  - o Reduced setbacks (front yard from approximately 50 feet to 4-7 feet)
  - Waiver from right-of-way improvements on North Stagecoach and East Mission
- Community and Planning Group concerns:
  - o Fire hazard (property is in a very high fire hazard severity zone)
  - o Traffic congestion, especially near the elementary school
  - Limited evacuation routes in emergencies
  - o Incompatibility with Fallbrook's rural character
  - Inadequate infrastructure
  - o Parking concerns
  - o Potential for ADUs to increase density further
  - o Density,
  - o Architecture,
  - o Landscaping,
  - o ADU plans,
  - o Secondary access,
  - o Trails,
  - o Road/traffic improvements.
- School district representatives:
  - Bryson Bigler (School District): Asked for safety measures for students crossing the street
  - Maggie Taylor (School Principal): Requested sidewalks and construction scheduling that avoids school drop-off/pickup times
- The Planning Group unanimously voted to continue the item to a future meeting. Sean Kilkenny agreed to consider changes to the project, including architecture, landscaping, ADU plans, access, and trails. He committed not to move forward with county approval without returning to the Planning Group first.

- County zoning indicated they would accept the Planning Group's recommendation
- Some Planning Group members expressed concern that the sign was already built without permits
