- 1) CALL TO ORDER: James Chagala, Chair
- 2) ROLL CALL: Quorum establishment

- 4) MINUTES
  - a) Approval of minutes of March 25, 2021

    Caster motioned to approve the minutes from March 25<sup>th</sup>. Sealey second it. Chagala abstained. Birch, Gutierrez, Garland in favor. Cook absent. 5-1-1. Motioned approved.

- B. Rapp raised a concern regarding marijuana industry entering unincorporated area. Chagala mentioned that this topic is part of the meeting agenda today and asked of B. Rapp would like to comment when that agenda item comes up. B. Rapp agreed.
- K. Lippit commented that we are lucky to have Desmond as supervisor the only person standing up for the rights of residents in unincorporated area and encouraged to attend the board of supervisors meeting
- 6) ADMINISTRATIVE ITEMS/CORRESPONDENCE
  - a) Training Status all training is complete
  - b) VMT's at Board of Supervisors\* State passed the regulation that we have to use VMT in determining significant impact for traffic. Going to the Board on May 19th

- c) Housing and Safety Element at Planning Commission\* this is coming out on May 14<sup>th</sup> for discussion with planning commission. Goes to the Board of Supervisors sometime in June.
- d) Meeting with Supervisor Desmond re: Cannabis Ordinance Chagala will try to get a staff person out to cover Cannabis Ordinance.

Public Comments:

- B. Rapp raised concern regarding marijuana industry entering unincorporated area: concern about consumption lounges, traffic, driving under the influence and effect on teens.
- K. Lippit commented on the supervisor that is trying to approve his ordinance. Commented that it would result in increased addiction, youth use, increase in crime. Commented on limits on THC and flavored products targeting youth. Expressed hope for a call for cost / benefit analysis.
- J. Strang expressed concern about a link to have marijuana industry as a way of reparations, aka minorities can have marijuana businesses.

Birch commented on the signal light at Champagne Blvd. There will be a dedicated turn light put in 3-4 weeks

Birch shared observation on Champagne Blvd traffic speed and brief comment on whether to relocate the signs or put up more signs.
