1. Park Land Dedication Ordinance (PLDO) presentation by San Diego County Department of Parks and Recreation (DPR). (Although DPR originally requested our priority list by December 30, 2021, they will allow us an extension until Jan 14, 2022 so we can finalize our priority list at our January 10, 2022 JCSG meeting.)

2. Update from the Ad Hoc Community Benefits Subcommittee to include the tabulated results of the bilingual community benefits/energy usage survey.

3. Review/approve the administrative permit for the Rosenberg fence (PDS2019-AD-19-025), 44673 El Centro Ave, Jacumba.

4. Discuss the Voters Choice Act (ACT) and the upcoming public consultation meetings that are required before the County's new election administration plan is implemented in June 2022. Under this plan, every active registered voter in San Diego County will automatically receive a ballot in the mail nearly a month before Election Day. Ballots can then be returned by mail, or at a secure Ballot Drop Off Location, or at a Vote Center near you. Why the change? The County of San Diego Board of Supervisors directed the Registrar of Voters to transition to the Voter's Choice Act model on October 19, 2021.
