--Discuss the need to place community benefit money in an interim escrow account until a detailed benefit management plan has been developed by JCSG (and the community) and approved by PDS. **Vote on whether to recommend that PDS place \$3.55 million dollars in undesignated JVR community benefit money in an interim escrow account.**

--Identify a date for a future Sunday townhall/special JCSG meeting to: Educate residents on the types of community benefits, the advantages of investing some portion of the benefit monies, and solicit more ideas from residents regarding possible community benefits.
