**2. On November 20 at 2 pm, the CPUC will hold a virtual public forum on SDG&E's proposal to add a new income-based fixed monthly charge.** If approved by the CPUC, these monthly charges would be added to customers' bills before a single kilowatt-hour is applied. (Customers with incomes up to \$69K would pay \$34; incomes up to \$180K would pay \$73; incomes over \$180K would pay \$128.) She also submitted a similar request to DPW for the funding of these road improvements on November 6, 2023.
