1. Michael Casinelli, Chair, called the meeting to order at 7:30 p.m.

**3. APPROVAL** of the agenda for October 9, 2018 and minutes for the meeting of September 25, 2018. Motion carried unanimously

#### 4. OPEN FORUM

- **a.** Rich Marzec will be absent for the November 13 meeting.
- **b. Bill Herde** reported that the shooting ban on BLM area passed the BOS 3/2.
- c. Hannah Gbeh shared some news from Community Social media pages that over the weekend there was an incident involving a Deerhorn Valley family when three big men carrying backpacks attempted to cross their property early in the morning. US Border Patrol agents were able to apprehend these men who were found to be Undocumented Aliens (UDAs). The USBP provided information, which she passed along to our JDCPG as follows: The USBP reports that the number of UDAs traveling through the Deerhorn Valley area has substantially increased as of late. Residents should be vigilant and call USBP for suspicious behavior. Most of the activity has been found to occur over weekends, during full moon, and before/after a holiday. UDAs are passing through heavily brushed areas and currently heading towards Honey Springs Road and Lower Deerhorn Valley Road, where they are picked up. - **d. Joe Stuyvesant** received an email regarding new Border Patrol Station from John Petrella from which he shared the following. - **e. Darren Greenhalgh** went to the SDG&E workshop on the wild fire shutdown policy. They had a number of things going on. They are trying to get the distribution lines to change to 6-foot from current 3-foot for safety. Weather stations have been set up where they are keeping track of humidity and moisture vegetation and putting it into a program which should let them know when it would be necessary to shut down the power. The parameters are set and the process has to go to the top before the power would be shut down. They have a ten-day advance warning and will give us a two day warning before shutting down. They are in the process of locating eight locations in the back country where you could go and get use of a generator (six would be in southern division closest to us would be Dulzura) They have been trying to isolate the circuits that would not be shut off except in very high wind, and have set up separate circuit breaker for that area. They do have an app that will tell people when the power is expected back on.
- f. Eileen Poole reminded us that the annual parade will be on Sunday, Oct. 14 and Lyons Valley Road will be closed during the Parade and no traffic allowed.
- g. Michael Casinelli announced that Jim Bolz will be here with the traffic engineer to discuss the Lyons Valley Rd/Jamul Drive Signal at the next meeting.
- 5. DISCRETIONARY PERMIT FOR ADMINISTRATIVE PERMIT PDS2018-AD-18-018, 3243 Heide Lane Jamul, fence height Bill Herde Mishler Residence They are doing remodeling and want to do a fence a little higher than normal. The impacted neighbor was contacted and found no problems with the height. Dan Neirinckx asked what kind of fence. Bill Herde said that it is a privacy fence (stucco finish wall) and okayed by the fire department. It is 6' fence. Darren Greenhalgh asked distance rom paved road 14 feet. Steve Wragg recused himself due to previous work with the family. Bill Herde moved that we recommend approval of this fence without conditions. Motion carried 10-0-1 abstention Wragg.
- 6. PLANNING COMMISSION HEARING, scheduled October 19, 2018 regarding Village 14 and Planning Areas 16 & 19, discussion Dan Neirinckx, chair of subcommittee was still unable to download the staff report and therefore our comments

would need to be just a repeat of what we stated as a Planning Group. It starts at 9 a.m. but people need to be present before 8:45. He would suggest that we need to re-enforce our previous position and give a presentation of our concerns and be available for questions from the Planning Commission for example re Proctor Valley Road. He would suggest that it be Michael, Dan and one other be present from the JDCPG. Our JDCPG asked many questions for which we have not seen the answers...**Rob Cameron** will send us the comments from the County Staff which are online. Steve Wragg pointed out that we recommended approval with conditions including offsite mitigation of traffic and septic vs sewer questions. Michael Casinelli pointed out that there were other questions we asked and Steve Wragg suggested we make sure that we know what our concerns and their answers to those issues. Hannah Gbeh asked whether there were any changes due to public comments. Ms Jackson, developer, pointed out that there were no changes in the projects. **Hannah Gbeh** asked if any of our concerns were addressed as a mitigation measure and Rob Cameron said no. She recommends we come across clearly and concisely. Joe Stuyvesant recommends that we go in pointing out that we recommended approval but had these legitimate concerns and address whether or not they were adequately responed to in the Final EIR. **Darren** Greenhalgh pointed out that the County makes the decision and our argument would be with the County. Michael Casinelli as Chair and Dan Neirinckx as Sub-committee Chair will be at the Planning Commission to represent our JDCPG and answer any questions from the Planning Commission. Michael Casinelli made the comment that he is concerned that the Planning Group had to make recommendations before receiving the Staff Report and yet then the Planning Commission hearing was postponed and we still don't have some of the answers to our questions.
