We are interested in hearing from the Jamul Dulzura Community not only on the proposed project but also on the impacts from the current casino. This will help us respond to "cumulative effects" from the expansion project.

The Jamul Indian Village of California's Reservation is located at 14,145 Campo Road, Jamul, CA 91935. The Project proposes to remodel the existing Jamul Casino to include a new event center, multi-purpose/bingo hall creating an additional 35,000 SF on a new 3rd floor, a 225-room 16 story hotel 225 FT above ground on the west side, six-story parking structure on the south edge, and associated infrastructure of an additional treatment facility and storm drain retention. Construction activities are proposed to commence in <a href="December 2022">December 2022</a> and are anticipated to take place over 18-24 months. No expansion of the gaming floor or increase in the number of slot machines or table games is proposed.
