### 3. APPROVAL OF MINUTES: March 4 and March 18, 2025

### 4. OPEN FORUM

- Chair Lisa Hodgson read a letter from SDGE concerning how the timeline for Strategic Undergrounding has changed due to fewer miles being approved for funding. Rate payers should be receiving updates soon via email/mail. Lisa is planning to ask SDGE to return to an upcoming meeting soon.
- Michael Casinelli shared an update about the new proposed Community Park. He met with the superintendent, who will discuss an updated site with the school board at an upcoming board meeting. Original parcel: more costly due to numerous reasons. The newer site has better access to parking but has no access during school hours. We are waiting to see how things go with the school district before any other information can be shared.
- Preston Brown said the Sierra Club and a coalition of environmental nonprofits
  including the Endangered Habitats League and the California Attorney General's Office
  announced a legal settlement regarding the Otay Ranch Village 13 master planned
  community north of the Otay Reservoir. It will enhance environmental protections and
  provide safeguards for endangered species, while simultaneously increasing the
  opportunity for new housing in the region.

The agreement substantially reduces the footprint of the proposed housing development, preserving approximately 300 additional acres of open space and the settlement simultaneously allows the developer flexibility to add additional units. The developer

may apply for up to 2,750 housing units (increased from 1,938) within the same building area, allowing for additional housing supply while reducing environmental impacts.

#### 5. LETTERHEAD LOGO FOR JDCPG

The new Logo for our Planning Group was approved at the last meeting. It will be included in future Minutes.

### 6. <u>WILDFIRE AND EMERGENCY EVACUATIONTOUR WITH SANDAG AND</u> CALTRANS – SR-94

Vice Chair Paul Dombkowski shared the following updates:

- SR 94 brush clearing/tree trimming continues from Lyons Valley Road to Steele Canyon Road. Brush clearing/tree trimming from Otay Lakes Road through to Dulzura is still on hold as Caltrans continues their investigation of cultural sites located on this stretch of SR-94.
- Paul provided an update on the Dulzura Town Center speeding issue. Paul is in direct contact with the new El Cajon Area CHP Commander Captain Michael Monte Agundo, who confirmed that they have increased CHP presence along SR-94 near the Dulzura mini mart. The CHP have issued 25 citations for speeding over the past weekend. The CHP will continue to increase their presence along this Dulzura stretch of SR-94 throughout the week and on weekends.
- Lance Hafen shared that the speed limit on SR-94 needs to be clearly marked. The current speed limit is 55 mph.
- Chair Lisa Hodgson stated that she had shared the SD County workshop information about speed limit reductions with Dulzura via Facebook messenger. The reductions in speed limits are being done in conjunction with the California Highway Patrol and it aims to reduce traffic accidents and injuries by reducing speed limits by 5 miles an hour in specific areas around the county. This initiative is the result of AB 43 passed in 2022.
- Paul shared highlights from the most recent SANDAG Board March 2025 Meetings. Mario Orso, CEO, SANDAG, mentioned SB 375 and discussed whether SANDAG should use VMT in its General Plan going forward.
  - Rep. Carl DeMaio and Senator Brian Jones have both introduced bills focused on giving the unincorporated areas a vote through the APG. Of note, there is considerable support from other SANDAG Board members with very little opposition to date.

## 8. <u>JAMUL CASINO HOTEL AND ENTERTAINMENT CENTER EXPANSION PROJECT</u> Night time light pollution from the Jamul Casino is an increasing concern among Jamul residents.

Preston Brown consulted with <u>Travis Longcore</u>, the Science Director of The Urban Wildlands Group, a Los Angeles-based conservation nonprofit, and an independent ecological design and environmental policy consultant. Dr. Longcore is a world leader in the environmental and ecological effects of night lighting, including the disruption of behavioral and physiological processes across species. Dr. Longcore was quickly able to pull data from the website <u>DarkSky.org</u> showing the dramatic increase in nighttime light pollution since the opening of the Jamul Casino in 2016. Long term onsite follow-up studies will be needed to determine impacts to wildlife in the area.

**Preston** stated that the annual migration season of many bird species is occurring from March 1 through June 16th. He shared information about "Lights Out San Diego", an event that encourages residents to decrease outdoor lighting. More information can be found at "Lights Out, San Diego". **Preston** has volunteered to write a letter to the Jamul Indian Village/ Jamul Casino regarding the effects of light pollution from the recent additions of nighttime lighting themes to the Casino and Hotel and the addition of the new Jamul Casino Sign.

Our group will continue to monitor and follow up with the JIV and the wildlife agencies whose conservation lands could be negatively affected.



Dear County of San Diego, PDS:

The Jamul-Dulzura Community Planning Group favors Alternative 4 by a vote of 8-3.

While our recommendation is Alternative 4, we also believe that the Draft Environmental Impact

Report (DEIR) fails to adequately address topics which have been discussed in the DEIR and

Regulatory Comments. In particular:

- 1. The effects and impacts to our rural roads and infrastructure.
- 2. The negative effects from impaired drivers who have visited cannabis lounges and temporary events.
- 3. The negative environmental effects of cannabis cultivation on utilities, rural aesthetics and

surrounding residents and businesses.

- 4. The negative impacts of outdoor temporary events.
- 5. The negative environmental effects of cannabis cultivation odors.
- 6. Negative effects on other crops.
- 7. Negative effects on law enforcement, first responders and public services.

We recommend that the EIR be revised to include a more thorough and up to date analysis of these topics and their negative environmental impacts on our unincorporated communities.

I am writing on behalf of the Jamul-Dulzura Community Planning Group (JDCPG) to express our full support for the Board of Supervisors to approve and implement enhancements to the Unsafe Camping Ordinance, a critical measure to enhance public safety and protect our shared communities from the growing threat of wildfires. With the vast majority of the unincorporated areas in the High Fire Threat District, your commitment to addressing illegal encampments in these fire-prone areas is essential to safeguarding lives, homes, and natural resources.

Recent wildfires, including the Border 2 Fire, Lilac Fire and Center Fire have shown the devastating impact of encampments in fire-prone areas. Your effort takes a proactive approach by empowering law enforcement to remove potentially dangerous illegal encampments, clear hazardous areas, and prevent future disasters.

Your efforts are further reinforced by recent legal and policy developments, including the U.S. Supreme Court's decision in City of Grants Pass v. Johnson and Governor Newsom's Executive Order encouraging local governments to take decisive action on encampments regardless of if shelter beds are available. By aligning with regional efforts and providing law enforcement with the necessary tools, we can prevent avoidable tragedies and create safer communities for all residents.
