## E. Action items (JCPG advisory vote may be taken on the following items)

### 1) Appointment of Planning Group representative to the ARB (Chairman Brown)

Moretti moved the JCPG nominate Munshi as JCPG Representative to the ARB

### 2) Participation in County Comprehensive Broadband Plan (Special Meeting)

The Group decided that at this point it isn't necessary for us to have a representative as they aren't currently considering anything that has to do with Julian, but we will continue to monitor progress. Munshi will ask them to schedule directly with the Library, and tell them we will apprise Planning Group but we feel it is not actually in our area of expertise.

### **3) Representative to San Dieguito River Park Joint Powers Authority**

As JCPG member Eric Jones is already on the SDRPJPA representing the Volcan Mountain Foundation and as the SDRPJPA currently does not deal with the Julian Planning Area it wasn't thought necessary to have another representative at this time.

## **F. Updates and Reports**

### **1) North County Working Draft MSCP (Vice Chairman Everett)**

Everett is continuing to monitor. Concern at the moment is that if you own property with a structure on it, you have the right to clear 5 acres. When the new plan is approved that will be reduced to 2 acres. Then you would have to apply for a clearing permit and mitigate impacts. Everett will do more detailed report; at some point in time we will need to decide what to support in the MSCP.

### **2) Spencer Valley School CALTRANS School Zone**

Everett put on the agenda because someone raised a concern about traffic there. Everett thought this wasn't within our purview.

### **3) Jess Martin Park PLDO funds (Loomis)**

Ricard Loomis, representative from Jess Martin said they had submitted a request for funds but hadn't heard. He was advised to go to Anderson's office. Moretti said we could ask the County about our list of priorities—asked Richard Loomis if he could do this.

## **G. Group Business – Information and Correspondences**

**1) Future JCPG meetings at Library Community Room – TBD.** Room isn't ready for meetings yet but they have a coded entry, so could have meetings after hours. Jess Martin Park is on their calendar every month.
