## 1) Annual Election of Officers

## 2) Draft North County MSCP

Stephanie Neal from county staff updated the Group on the status of the MSCP and answered questions from the Group and the public. Seifert made a motion to oppose implementation of the program plan in part due to the proposed reduction (five acres to two acres on improved parcels) of allowed (with no permit requirement) of fire-prone vegetation removal. Provisions of the plan were deemed to result in unacceptable additional fire risks to the community.

Approved: 6-2. Morales and Jones dissented.

## 3) Unsafe Comping Ordinance Letter of Support

No action was taken.

## 4) Release of Sexually Violent Predator (SVP) into Julian.

No action was taken.

## 5) Short Term Rentals (STRs)

Lee Ann Raddatz (Pine Hills resident) enumerated problems and issues related to the proliferation of STRs in her neighborhood, including crime, fire, dogs, threats to wildlife, garbage, noise, and emergency access. The Group has repeatedly requested that the County address these issues but requests have been ignored and to date. Apparently, the only action taken has been for the County to advise STR operators (those that are known) to pay their Transient Occupancy Taxes (TOT). A motion was made to request representatives of Supervisors Anderson and Desmond, and county staff, to attend a future meeting to address the issues and answer related questions.

Approved: 7-1. Morales dissented.
