 - **E. Action items** (JCPG advisory vote may be taken on the following items)
- 1) Supervisor Anderson's Fire Fee vote, Short Term Rentals and Draft North County MSCP (Andrew Hayes, Supervisor Anderson's Taxpayer Advocate)

Hayes noted that Supervisor Anderson voted in favor of increased fire fees despite planning group opposition. The Board of Supervisors approved the fee increase. It was noted that Julian was promised no increased fees when our fire district was dissolved, and over two million dollars of assets were transferred to the county in the dissolution. Item to be included as action item for July meeting.

The county tax collector is actively involved in recovering unpaid Transient Occupancy Tax (TOT) funds from Short Term Rentals (STRs) in Julian, however because there is no formal permitting nor records for STRs it is a difficult and non-comprehensive effort. Supervisor Anderson is looking into some form of registration/regulation for STRs countywide. Item to be included as action item for July meeting.

The draft North County MSCP was discussed. The planning group has expressed significant concerns regarding increased fire risk from proposed clearing allowance reductions. Item to be included as action item for July meeting.

No action was taken at this meeting.

2) Request for Exemption from Site Plan Requirements, Code Violation, Quecho

The project applicant and applicant's representative were not present at the meeting. A motion was made and seconded to recommend exemption.
