### 6. COUNTY PRESENTATIONS (Possible Vote)

- A. San Vicente Energy Storage Project San Diego County Water Authority
  - Neena Kuzmizh, Deputy Director of Energy Conservation. Presented plans to build a proposed water battery water is pumped up via solar energy and runs back down in order to create hydroelectric power to supplement solar energy during peak seasons of need. Proposed cost is \$2-2.5 billion. Current timeline has construction projected to begin in 2027. Open house will be help at Lakeside Community Center on Nov 10<sup>th</sup>.
  - Public Comments: Steve Gray: Water level may deplete overtime due to drought, why would taxpayers want to pay for this now? Neena- Investment would not be made until 2027.
  - Diane Conklin: Lives in Ramona (where project is projected to be located) does not want this project to be built on tribal and/or protected land.
  - Joseph Mitchell: Says that water battery projects are rare due to the high cost.
  - Frank Hilliker: Supports the project from the prospective of the lakeside water district as it will improve our energy grid.

- **B.** Time Extension PDS2022-TM-5203TE Hillside Meadows
  - Nick Gustofson presented the proposed time extension of three months. Original Project was proposed in 2002. The Planning Commission set to hear the proposal on Nov 9<sup>th</sup>, 2022. Planned project includes the development of 142 residential lots. Project has received numerous time extensions dating back to 2002. Proposed Map has currently expired and a time extension is needed to continue.
  - Tom Ferrara: Voice concerns in elevated traffic as original study was conducted and approved with 2002 traffic levels not current levels.
  - -Anna Leger: Asked Questions about how likely the proposal is to be developed as planned? What percentage will be affordable housing? Answer: Owner will sell lots to developers to meet market value with options to buy out affordability.
  - -Kelly Meyers: Lives on lots that would back up to the proposed development. Expressed concerns about fire safety and general safety of increasing the population in her immediate vicinity
  - -Robert Butetch: Expressed strong opposition to the project citing destruction of lakeside land, water usage, increased traffic, and property value of the surrounding area.
  - -Mr. Killkenny: Owner of land and project. This project was part of a larger San Diego County traffic planned in 2002. Biographical studies have already been adjudicated and approved, and the City of Santee will receive mitigation land. Water usage has been approved for usage of Padre
