The Board will be voting on seat number one in November, and the Chair will make sure that everybody has a copy of the applications that have been received to date. And then the board will be voting on seat eight in December.

Seat 1 will be filled in until 2024 and seat 8 will be until 2026. Candidates are applying for either one of those seats. If candidates are not elected for the first seat, they can still be a part of that process in December.

Qualified applicants will have until the following regularly scheduled CPG meeting to submit a written letter of application to the chair. And if there are more applicants than open seats, the board may, but is not required to take action on the vacancy at this time, which is the second meeting.

Applications for seat 8 will be closed at the next regularly scheduled meeting. So it would be up to that day. So seat 1 would be closed on October 4th. Any candidates the Board gets after this, after October 4th, would be considered for seat 8. Kristen and the committee should review the bylaws and add an addendum regarding when the application closes. Sasha said that the registrar has to verify and the board can't review people without having that certified, because those people may not even live in Lakeside.

Carol said whoever has approved applications prior to this meeting is eligible to. If we have the application and it's certified, the Board can interview those people. It must be submitted and approved prior to the November meeting.

F. Proposed CPG Advisory Position SANDAG Board of Directors

- Association of Planning Groups (APG) – Review Bylaws Vote on whether to officially join APG

The group is deciding now whether to join the Association of Planning Groups. This does not affect the community planning group's independence, and if the group participates with the association of planning groups, we remain independent and represent our constituents as we always have, the CPG role does not change. The CPG continues to review, vote, and advocate for their individual communities. The goal is to ensure consistent and effective representation and productive two-way communication between SANDAG and the unincorporated communities of the County of San Diego. The Association of Planning Groups will take positions on issues that apply to unincorporated areas based on the information that it receives from the plan. Lakeside would like to see some of those tax dollars be spent in our community, and that would be an item that the advisory position could communicate to the San Diego Board of Directors. We have county supervisors that represent the unincorporated areas, however, two county supervisors are assigned to the Sandag Board of Directors and are intended to represent not only the 500,000plus residents of the unincorporated area but also residents of the 18 cities whose mayors are already on the Sandag Board of Directors. It's considered a double representation, and it's a benefit that city residents receive, but not the unincorporated. There are 19 groups that should be represented from the rural areas. This association is only open to planning groups, not sponsor groups. Planning groups got support from our supervisor, Joel Anderson, and he lent us a staff member to help write these bylaws.
