6. OPEN FORUM

- Khania Donnell expressed appreciation for the community's involvement in the upcoming events related to public safety and local projects.
- Tony Santo shared insights regarding ongoing community initiatives and encouraged more residents to participate in planning meetings, highlighting the importance of having a community voice in local governance.
- Richard Abraham emphasized the significance of the Veteran's memorial project, detailing the careful discussions with the county to finalize its location. He indicated community support and excitement regarding the memorial's establishment.
- Ron Casper elaborated on the features of the new county park, including the construction of
 concrete pads for archery and related activities. He mentioned taking footage of the development
 process and underscored the park's safety for various recreational uses, such as archery and RC
 airplanes.
- Steve Robak urged those present to explore potential funding opportunities from USAID, which
 recently had resources geared towards community projects. He emphasized the importance of
 utilizing Parkland dedication funds for local initiatives but expressed uncertainty about the
 eligibility of certain projects.
- Kyle Hermann brought forth important legislation concerning public safety, particularly in rural San Diego County. He detailed several bills related to the treatment and placement of serious offenders, highlighting ongoing concerns in the community and legislative responses aiming to prioritize public safety.
- Joanna Aud focused on the need for infrastructural improvements on Pepper Drive. By referencing her organized platform, fixpepperdrive.org, she encouraged community members to visit the site to stay informed and engaged regarding the improvement efforts.
