F. Association of Planning Groups SANDAG Carol

Two bills are being sponsored regarding a SANDAG voting seat for the APG:

AB 24 (DeMaio)

This bill, introduced by Assemblymember Carl DeMaio, proposes modifying the SANDAG Board of Directors by removing one of the two County Board of Supervisors seats and replacing it with a representative from the San Diego County Association of Planning Groups. It would also require the remaining County Board representative to be from an unincorporated area of the county. The bill has been double-referred to the Assembly Local Government Committee and the Assembly Transportation Committee. It currently does not have a scheduled hearing date.

SB 240 (Jones)

This bill, introduced by Senate Minority Leader Brian Jones, proposes to replace the secondary representative from the County Board of Supervisors with a resident from an unincorporated area of the County, as selected by a majority of the county's community planning groups, to serve a 1-year term. The bill also eliminates the requirement that one Board of Supervisors member be from a substantially incorporated district and the other from an unincorporated district. This bill has not yet been referred to a policy committee in the Senate.

The APG will continue to monitor these bills and provide updates accordingly.
