Introduced herself as the new district representative replacing Kyle Herman. Shared updates on recent legislative activity, including:

SB 525 closes the gap between mobile homeowners and insurance coverage.

AB 586 establishes a legal framework for registering electric motorcycles as off-highway vehicles.

SB 380 strengthens placement and supervision requirements for sexually violent predators; ensures they remain in state-run facilities.

SB 79 allows transit-oriented housing development on mixed-use zoned properties (Senator Jones voted *no* on this).

Encouraged public engagement during the governor's bill review period and shared a constituent contact link.

Aline Nargizian - legislative update from San Diego County Supervisor Joel Anderson

Presented the Supervisor's 2024 Legislative Actions and Accomplishments booklet.

2025 Wildfire Town Hall: Event with Sheriff Martinez and SDG&E on fire prevention and safety.

AI Governance Framework: Supervisor Anderson is leading the responsible AI policy within the County. Gillespie Field Leases: Three major leases were approved in August 2025, streamlining local business growth. El Capitan Reservoir Proposal: County Parks to assume recreation management from the City of San Diego under a four-year pilot model.

Grant Programs: Neighborhood Reinvestment & Community Enhancement programs open for FY2025–26; over \$4.1M distributed in previous year.
