Project Scope: Time extension for the use permit and reclamation plan to align the term of the entitlements set to expire in March 2035.

Quarry employs approx. 30 full-time employees

Slaughterhouse Quarry expirations were set for 2020. New ownership in 2021. Reclamation includes revegetation, restoration and reduction of visual impact. State of California requires careful reclamation and is monitored by the state.

Alignment with State Law

- Bring the ADU Zoning Ordinance into closer alignment with updated California State Code.
- Ensure compliance with recent changes to State law.

Assembly Bill 1033 (2023):

- Opt-in Legislation
- Allows ADUs to be sold as condos
- Each unit receives a separate property tax bill
- Expands homeownership opportunities at more attainable price points

CONSIDERATIONS:

Not every property with ADU(s) will be appropriate for sale.

A lot split may be more appropriate depending on circumstances of property.

HOA creation could be cumbersome especially for only two members.

County permitting procedures can be lengthy and take too long to make option attractive.
