- A. Announcements and Correspondence Received – Chair Georgantas reported that he has forwarded all email correspondence from the County.
- B. Architectural Subcommittee – Ms. Malinowski reported that there is no update on date of Community Identification Sign program presentation to Board of Supervisors.
- C. Social Media Subcommittee – Ms. Malinowski reported that she continues to post agenda and minutes to Rainbow Cares. She reposted the Vacancy Notices for the two open seats.
- D. Parks and Beautification Subcommittee – Nothing new.
- E. I-15 Corridor Design Review Board – Mr. Doud reported that there was minimal activity.
- F. Roads and traffic status – Dr. Kurland reported that Richard Chin, Project Director, forecast that the traffic light project would be completed by fall, weather and supply chain permitting.
- G. Water and Environmental Issues Report – Dr. Kurland reported that the Water Quality Improvement project work continues.
- H. ARC Update & Community News – Nothing new.
- I. Cannabis and Social Equity Program update – Mr. Doud reported on the 10 May 2022 Board of Supervisors meeting regarding the Cannabis Taxation program. Changes to the proposed program need to be finalized by 14 Jun 2022 in order to appear on the Nov 2022 ballot, which is estimated to cost \$800,000 for printing, etc. Rainbow and Fallbrook Planning Group members are invited to tour a San Diego County licensed cannabis facility, arranged through Blue Water Government Affairs, a
