- I. Open Provisions
 - A. The meeting was called to order by Chair Paul Georgantas at 6:30 PM
 - B. Pledge of Allegiance
 - C. Attendance: Paul Georgantas, Lynne Malinowski, Frederick Rasp, Martin Kurland, Jon Gorr, Mark DiVecchio, Greg Doud, Doug Gastelum, Michele Sheehan. 7 members being present at beginning of meeting, a quorum is declared.
- II. Motion to approve the agenda by Dr. Kurland, second Mr. Rasp, approved unanimously.
- III. Public Comments

 - A. Motion to approve prior meeting minutes from 15 June 2022 made by Dr. Kurland, second Mr. Rasp, approved unanimously.

- VI. Old Business and Reports
 - A. Announcements and Correspondence Received Chair Georgantas reported that he has forwarded email correspondence from the County, none received in the mail.
 - B. Architectural Subcommittee Ms. Malinowski reported that there is no update on date of Community Identification Sign program presentation to Board of Supervisors.
 - C. Social Media Subcommittee Ms. Malinowski reported that she continues to post agenda and minutes to Rainbow Cares and will post openings again next month.
 - D. Parks and Beautification Subcommittee None.
 - E. I-15 Corridor Design Review Board Mr. Doud reported that there was minimal activity pending and meetings were not held during this period.
 - F. Roads and traffic status Dr. Kurland reported that he has not been able to reach Mr. Chin on the status of the traffic light. He received a response from Christopher Hanger of the County of San Diego regarding the 5th Street low water crossing bridge project: it was not awarded a grant under the Federal Highway Administration former grant program. The DPW continues to seek grants and other funding opportunities to design and construct a bridge at that location, are aware of the past fatalities, and acknowledges that this is the 2nd highest priority project on the 'Rainbow Capital Improvement Priority List.'

- I. Cannabis and Social Equity Program update Mr. Doud reported on the 28 Jun 2022 Board of Supervisors meeting regarding the Cannabis Taxation program. The language for the November 2022 ballot measure was finalized. The County is looking for a new manager of the Social Equity program.
- J. Vallecitos School District Update Dr. Kurland reported that the Superintendent, Dr. Maritza Koeppen, has resigned to take a position in another district. A replacement will be sought.
