MINUTES of Regular Meeting

- I. Open Provisions
 - A. The meeting was called to order by Chair Kurland at 6:30 PM.
 - B. Pledge of Allegiance
 - C. Attendance: Present: Marty Kurland, Greg Doud, Lynne Malinowski, Paul Georgantas, Michele Dahl, Frederick Rasp, Jon Gorr, Douglas Gastelum, and Ron Ehrler. Excused: Pat Eastman. 8 members being present, a quorum is declared.
- II. Motion to approve the agenda by Mr. Georgantas, second Mr. Rasp, approved unanimously.
- III. Public Comments

- VI. Old Business and Reports
 - A. Announcements and Correspondence Received – Chair Kurland reported that he will be able to attend the Fire Summit meeting on June 20th hosted by Assemblyperson DeMaio.
 - B. Architectural Subcommittee – Ms. Malinowski – Nothing new.
 - C. Social Media and Membership Subcommittee – Ms. Malinowski – Nothing new.
 - D. Parks and Beautification Subcommittee – Ms. Dahl – Nothing new.
 - E. I-15 Corridor Design Review Board – Mr. Doud reported that there were no meetings.
 - F. Roads and traffic status – Chair Kurland – Nothing new.
 - G. Water and Environmental Issues Report – Chair Kurland – Nothing new.
 - H. Community News and Grange – Ms. Dahl reported that the Rainbow Valley Grange will host an 85th Founding Anniversary BBQ on 7/19/25. The reroofing on the Grange is being scheduled. She asked for recommendations for licensed contractors for the interior work.
 - I. Cannabis and Social Equity Program update – Mr. Doud reported that there will be an SD County webinar on 6/25/25 to provide a recap of the public feedback and the next steps. Since it will be recorded, Mr. Doud will provide the link to the group. At this time, we will not request any presentation for this material to the Rainbow CPG.
 - J. Vallecitos School District Update – Chair Kurland reported that school is recessed for summer. They are trying to get a 0% interest loan for the solar system.

Purpose of Planning and Sponsor Groups: Advise the County on discretionary projects as well as on planning and land use matters that are important to their community.

- K. Fire Safety Council Update – Mr. Doud reported that a \$20,000 grant was received to cover 240 reflective signs, 3 chipping days, and 4 community events. Still expectation to receive NCFPD grants to cover website and other administrative costs. The next chipping day will be on 6/28/25.
- L. APG & SANDAG Advisory Seat for Unincorporated Communities – Ms. Malinowski reported on the 5/31/25 in-person meeting on May 31, 2025. There are 2 bills in the CA State legislature to substitute one of the SD BOS seats with that of an APG voting seat, but both are currently being slow walked. APG representatives continue to push SANDAG for statistics on past, present, and planned projects benefiting the unincorporated region. An Ad Hoc committee was formed to review issues among CSPGs.
- M. Regional Study of Rainbow traffic concerns – Ms. Malinowski reported on response received from the DPW about the Rainbow Heights Rd traffic survey. The road may be eligible for a posted speed limit. To support this, they have requested additional data to complete the evaluation. It is possible that the findings will be presented at the August Traffic Advisory Committee meeting.
- N. County Code Enforcement – Mr. Doud – Nothing new.
- O. Signs in the Rights of Way – Mr. Doud reported that a repeat sign violator has returned, and the County will contact them.
- P. Member/Administrative Reports – Chair Kurland. Ms. Malinowski reported on the 6/14/25 Quarterly Chairs meeting and forwarded the meeting slides to the group. Key issues of concern for attendees were the Battery Energy Storage Systems, Zoning Ordinance Amendment for Amplified Music at Boutique Wineries, no PLDO fees charged for senior home developments.
