V. County Action Items

a. Trip report- Rainbow traffic and road hazard mitigation status. The County has assured us that roadside growth that obstructs vision can be removed by the county quickly if in the right of way. Obstructions on private property can be removed by the county after proper notification to the property owner.

Chairman Drake processes a power point display of trouble spots around Rainbow that he generated last month. Review of the fact that signs can go onto private land adjacent to the road. Comments were made about lessons that can be drawn from recent accidents on Rice Canyon. Wear seatbelts. Don't Drink and Drive. Slow down in hazardous areas. Putting a cross at Dead Man's curve was also discussed. The idea of funding private signs within view of the roads that are hazardous was raised and it was suggested we put a request in Jonnie's Rainbow website. Other hazards were brought up such as NB at Rice Canyon and Rainbow Heights, the restricted view at the Realty Office, and SB at the side street connected to Rainbow Blvd near the Gas Plant (left visibility from the side street is poor).

Paul Georgantas will call the County about tree removal.

b. San Louis Rey Water quality improvement project. It was proposed and approved that the

RPCPG send a letter to Water Quality Board joining with the provisions of the Water Quality Improvement Plan.

c. Filing requirements of open seats by those up for renewal and election for the first time need to be sought out with the Registrar of Voters in time for the November election.
