- 1) Call to order at 6:30 pm by the Chairperson, Jim Cooper
- 2) Pledge of Allegiance led by Lynn Hopewell
- 3) Determination of quorum: Present: Jim Cooper, Lynn Hopewell, Cheryl Wegner, Ken Brennecke, Casey Lynch, Dan Summers. Excused absence: Dawn Perfect
- 4) Approval of the minutes of January 23, 2018 minutes: Motion to approve with changes as noted in item 7.f in BOLD by Lynn Hopewell, Seconded Cheryl Wegner. Motion carried 5-0-0-1 Casey Lynch abstained

- 6) Presentations from the public on non-agenda items only None
- 7) ACTION ITEMS
- a. Review of 13th Street Bridge Project at 30 percent Design Completion Update from County Staff and Discussion. (Michael Khoury and James Bolz, County of San Diego). Agreement to discuss after item 7.c to allow the County representative to attend.
- b. Review of Ramona Resurfacing list by Ad Hoc Committee to now include the greater study identified by the County letter dated November 7, 2017 and entitled: PRIORITIZATION REQUEST FOR ROADWAY PAVEMENT MAINTENANCE IN THE RAMONA COMMUNITY PLANNING GROUP (CPG) AREA. This report was sent to all sub-committee members in advance of this meeting to allow a pre-reading of this lengthy report. Motion made by Dan Summers to approve as submitted, seconded by Lynn Hopewell. Motion carried 6-0-0-0

c. Discussion of Highway 67 in Poway and Lakeside

Jim Cooper stated that many in Ramona believe that the RCPG is responsible for Hwy 67 from Cloudy Moon all the way to Poway Road.

Dan Summers pointed out that the planned widening of Hwy 67 has been postponed again until 2050. Also, that funding for rural Caltrans highway projects is thwarted by a state requirement that designates funds to be spent where it will do the most good for the highest number of people leaving rural projects at the back of the line.

Casey Lynch then brought up a fresh idea. If state funds are not available, there may be another way. The Trump Administration has announced its intent to pursue infrastructure improvements all over America. Might Ramona qualify for those funds? Ramona has outgrown Hwy 67 for ingress, egress and emergency evacuation and with Cummings Ranch and Montecito on the horizon, it will only get worse.

Jim Cooper mentioned that TV Channel 8 had recently interviewed Jim Piva with this recent Federal Roads interest in mind, and that Hwy 67 had been identified by Channel 8 as a road that might qualify for this renewed Federal Program interest.

Jim Cooper proposed that the T&T committee request a letter be sent by the RCPG to Diane Jacob to chair a meeting to include all stakeholders in the Hwy 67 issue to include developers, Caltrans, SANDAG, RCPG, Poway City Council, and appropriate federal and state representatives to petition the Trump Administration to include the widening of Hwy 67 in their plans.

A motion was made to this effect – To request letter from RCPG to Supervisor Jacob to host a Transportation Summit meeting regarding Highway 67 was made by Casey Lynch, and seconded- Dan Summers. Motion carried 6-0-0-0

a. Review of 13th Street Bridge Project at 30 percent Design Completion Update from County Staff and Discussion. (Michael Khoury and James Bolz, County of San Diego). Agreement to discuss after item 7.c to allow the County representative to attend. County representative not present, topic tabled.

8. Concerns from Members:

Dan Summers brought up the delay in receiving a status report from Caltrans to a letter from the RCPG regarding the boulder issue on Hwy 67. The RCPG letter was sent to Caltrans on August 25, 2017 six months ago with no response to my knowledge. Also, The RCPG sent a letter to Caltrans on October 6, 2017 regarding consideration for a concrete median on the Hwy 67 curve between Cloudy Moon Drive and Rock House Road. It has been nearly five months and again, to my knowledge, no response has been received.

It is the consensus of the T&T committee that the RCPG should send a letter to Caltrans requesting status reports on these two issues.

Report from the T&T Sub-Committee's AdHoc committee created to study two DPW Roads resurfacing Plan Updates as identified below:

On 5 Oct 2017, the Chairperson of the RCPG received an email with the subject of COUNTY OF SAN DIEGO ANNUAL ROAD RESURFACING PROGRAM UPDATE that included a listing of roads distributed for review and comment.

During the RCPG meeting of 2 November 2017, and AdHoc committee was created by the RCPG under the T&T Sub-Committee to accomplish this task.

The results of this effort are included with this report as attachment A.

During the T&T Sub-Committee's meeting on 28 November 2017, the Chairperson RCPG delivered a letter from the San Diego County DPW dated 7 November 2017 entitled PRIORITIZATION REQUEST FOR ROADWAY PAVEMENT MAINTENANCE IN THE RAMONA COMMUNITY PLANNING GROUP (CPG) AREA. No action was taken at that T&T sub-committee meeting other than develop a suggestion that the standing AdHoc committee take this for action if approved by the upcoming RCPG meeting of 7 December 2017; which was granted.

Also since this deadline was 45 days from the date of the letter, a formal request was made and supported for an extended deadline of early March 2018.

Efforts began to obtain copies of the various related documents to include an exact copy of the roadways map (in color) from the County, which was accomplished and distributed to the AdHoc committee members near the end of December.

A roads listing for those within the SDCEs was sent to the prior SDCE support person that helped with the first list also, for input.

The AdHoc committee met on February 6, 2018 and made some final decisions on the recommendations that they were going to make to the T&T Sub-committee on 23 January 2018, and then to be forwarded to the RCPG, with a goal of having this done for the 1 February 2018 RCPG meeting.

This second set of results/recommendations is included in this report as attachment B.

This concludes the chartered action of this AdHoc sub-ccomittee under the RCPG T&T sub-committee. The results will be reported out at the February T&T sub-committee with final recommendations being presented at the March RCPG. At that time, unless further actions are assigned, this adhoc sub-committee will be absolved.

During these deliberations, some AdHoc sub-committee members received several negative comments from the public regarding the condition of the recent over-pavement activities on Keyes Road, Ashley Road onto Seventh, and others. In specific, the roads have taken on a rolling/rocking aspect that was not there before the over-pavement. It is strongly recommended that the County Public Works Department review these road conditions before further over-pavement works result in the same unsatisfactory conditions.
