8. WAIVER REQUESTS

a. New Signs - Kahoots - 2020 Main St. - Gregg Grandon

Proponent states the building is 85 feet from the curb of Main Street. Proposed signage is 24 inches Channel lit letters (allowable size is 12 inch). Lewallen stated he is ok with the size being 24 inches since there is one sign only and due to scope and scale the 24 inches would be more fitting.

Larson stated he was ok with the lettering size as well. Ensign concurred. Motion to approve by Cooper 2nd by Ensign Motion passed 7-0-0

b. 500 Gal. Propane Tank - Arco - 1015 Main St. (return) Harry Heady

removal of the proposed propane tank and moved to the recommended area and to lay it on the side (horizontally vs vertical) on the southwest side of the property (KFC side). Owners are considering the propane tank to have a mural placed on it through Ramona HEART Murals. The EC85 signs are removed with the LED lighting and replaced by 2 sandwich boards each 55"x40" (allowable size is 42"x26") letter sizes not larger than 12 inches. They are trying to add to the new Arco sign but they may not be allowed to do so by weights and measures. Car Wash is still on the table and they plan to come back in 2018 with the plan for the car wash. E85 needs to be marketed and the proponents are working with their

attorneys and Arco Corporate to try and get the E85 info on the monument sign. The internally illuminated sign on the southwest side of the building needs to be removed as requested to come into compliance at time of Canopy replacement.

Anderson commented that the internally illuminated sign on the southwest side once removed can be replaced with "art" if approved by the board.

Motion made by Anderson, to approve one sandwich board maximum of $42"\times26"$ with letters not to exceed 12" high (with a subcommittee to review and sign off if in compliance with the motion prior to January 2018 meeting, approve the propane tank placed on the southwest side of the property horizontally placed and to remove the internally illuminated sign on the southwest side of building. 2^{nd} by Cooper. 7-0-0-0 motion passed

- c. New Temp. Sign North County Health Services 220 Rotanzi St. Joseph Parish
 Banner will be used when they open the facility and the sandwich sign will be used instead of the banner
 after the 45 day period is finished. Letter are less than 12 inches high and the sandwich board is
 42×26. Motion by Cooper to approve as submitted. 2nd by Gammon. 7-0-0-0
- d. New Sign & Paint Old Resurrected Rustic 948 Main St. (return) Kurt Meyers Myers did not show and told Lewallen that if he makes the meeting he will show, if someone else makes the meeting he will not be there.

9. PRELIMINARY REVIEW

a. New Business - Southeast corner - Hunter & Main - Jeff Carpenter

The vernal pool on site is to be saved and protect it with landscaping. Larson stated less stucco and more design breaking up the stucco. Mural would be nice on the Hunter side or you will need to break it up and have offsets. The building will have a visual impact all the way around. Break up some of the roof lines. Fowler: Signage should be facing Main street. Property is in V5. They get 91sf of total signage. We will need to see drawings on the signage and limited to 12 inch letter height unless more than 100 feet off the street. The Street is Kelly that the building wants to position the signage not Main Street. Larson is concerned that there is no signage on Main Street. Larson recommended a monument sign on Main Street so no signage is needed.

b. Building Remodel - 1236 Main - New Design Concept (return) - David Kniff / Marcie Laws

They have changed thinking on the project. The drive way that leads in to the group of parking will be eliminated and the circulation will be where the current u-haul lot is. They are doing this due to the childcare safety. They are asking for a 10 foot landscaped frontage (verses 0-2 feet) and in return are asking for the wall to be 8 feet high (6 foot allowed). This is designed to be an adult and child care facility. Cooper: Kids will be separate from Adults in some areas. The outside area is a joint use (intergenerational). The upper floor is office space. Will the windows be looking onto the children's play area? Answer by proponent is yes there will be windows that look down on the area. Concern is Megan's Law issues by Cooper.
