- 1. Call to order – meeting was called to order by Dan Summers at 6:03 pm
- 2. Pledge of Allegiance – was led by Torry Brean
- 3. Determination of members present

Attendees: Torry Brean, Debbie Foster, Lynn Hopewell, Maya Phillips, and Dan Summers

Absent: Robin Joy Maxson and Elio Noyas

- Motion to approve the order of the agenda motion made by Torry Brean, 2nd by 4. Lynn Hopewell. Motion approved 5-0-0-2 (Robin Joy Maxson and Elio Noyas absent)
- 5. Motion to approve or alter the minutes from June 23, 2021 – motion to approve made by Lynn Hopewell, 2nd by Torry Brean. Motion approved 4-0-1-2 (Maya Phillips abstained as she didn't attend, Robin Joy Maxson and Elio Noyas absent.)
- 6. Comments from the public on non-agenda items – None
- 7. Monthly update from Marvin Canton Marvin Canton introduced Victor Mercado, the Interim Director and who Marvin reports to. Dan Summers said he is very happy with the micro surfacing project on Hwv 67.
 - a. Major resurfacing project Marvin Canton shared that right now they're still working on the changes and doesn't have any updates. Due to limited staff that could attend Marvin postponed the environmental documents meeting. The meeting will now take place in August. Marvin continues to work on the permit to enter and it's an ongoing project right now. They sent out 900 letters requesting access and of those 12 property owners denied access. They're working on acquiring permits to enter. They have eight parcels they weren't able to enter. They hope to start work in October. Dan asked about the working group and is it comprised of all the players, like Office of Emergency Services (OES), Highway Patrol, CalFire, and Sheriffs Dept. Are they part of the workforce, is that correct? Marvin said they are the technical working group. With them took the modeling and

determined what would work, next step is to present to CalTrans development, they have to get approval to send forward. Marvin's concern is that many are on vacation and wants to make sure all the members are available to attend and share their thoughts. Dan asked if he has a date for the meeting. Marvin is looking at either the first or second week of August, so he has as many members as possible attending. Dan believes that there were seven alternatives. Two would not work during an evacuation. Marvin said the alternatives might work for something else but might not work for us. Torry Brean said it pertains to the ratio of residents that have been cooperative, and it sounds that it's been positive. Marvin said the first time he sent letters he spent a day talking to property owners. A lot of them are open. They have 12 owners that own 39 parcels. Torry asked about multiple property owners with multiple properties, is it undeveloped land, is it frontage? Thinks it would be of a benefit to them. Marvin, most of them are ready for it, not everyone's feedback is positive, some are for the change and others aren't. A couple property owners have six parcels and they're waiting on them. Every month they give a certain amount of time and then go back the next month to see where the property owners are at. They are indicating on a map showing all the property owners that have given them permission so they can start the process. Dan, if an individual who receives a permit to enter, if they deny how much of a road block is it. Marvin it's a hard question to answer, environmental would have to handle. If one parcel says no and another says yes, next door, then environmental can do study.

- b. Micro-resurfacing project
 Marvin shared that by this Friday, July 30, 2021 they should be back finishing the stripping on the micro surfacing.
- 8. Update on Zoom meetings with SANDAG Mayors
 Dan Summers shared that we have been reaching out to National City Mayor
 Alejandra Sotelo-Solis. She has agreed to meet with us via Zoom on August 10,
 2021, at 1:30pm. Dan will send out Zoom numbers as the date gets closer. We're
 unable to meet with San Diego Mayor Todd Gloria but can meet with his
 representative Keith Corry once he returns from vacation.

Torry Brean believes these are the two most important people to meet with. Happy to hear that we're meeting with Mayor Gloria's representative and Mayor Sotelo-Solis. Torry suggested including the tribes from Warner Springs, Santa Ysabel, and Mesa Grande. Believes there's seven or eight other tribes out there. Dan said he'll see what tribes are in East County and add them. Debbie Foster asked if Dan has heard anything about the plan for moving California all electric. If electric is off and everyone's car is electric. How do you evacuate. Torry thinks we need to double down on social equity.

- 9. Report on SANDAG appearance on 7/23/21 Dan Summers attended the SANDAG meeting on July 23, 2021, thinking they were back to public meetings and unfortunately, they weren't. He was able to get on the public comments line, and had a three-minute speech, but only got one minute. He complimented Marvin Canto and Mr. Pinada and the people running the monthly meetings on the San Vicente corridor. What a great job they're doing and how they are accessible to the Ramona Community Planning Group (RCPG). Dan plans to attend future meetings and discuss social equity.
- 10. San Vicente Corridor public workshop, August 11, 2021 Dan Summers shared that there's another public workshop for stakeholders. This is a meeting that a number of people from CalTrans will be attending, and they want input from the public. It's our opportunity to provide input regarding the Hwy 67 project. Dan sent us the information on this. Will be available on Zoom or telephonic.

 Dan Summers shared this information and they're listing priorities. It's our opportunity to share our thoughts about being overlooked and money being spent on the coast.
