- 7. Marvin Canton cancelled. He gave his report to Robin Maxson Who will share Marvin's input.
  - a. EIR surveying underway and doing well
  - b. The repaying of SR 67 with conduit is an active project to start in early summer 2022.
  - c. The Mina De Oro shoulder project has had contractor issues. It is now scheduled for 5/1 5/30.
  - d. The Clean California downtown business district projects including crosswalks, parking spaces, and enhanced signal lights are underway
  - e. Signage for the Mt. Woodson Hiking Trail is planned to be

installed as part of a package deal with the completion of the parking lots.

Lynn Hopewell- The Mt. Woodson Hiking Trail signage should not be delayed until the parking lots are finished. Not having directional signage is creating a hazard now and should not be postponed.

Robin Maxson makes a motion to pursue the installation of Mt. Woodson Trailhead signs immediately and not delay until the parking lots are built.

Lynn Hopewell seconds the motion and it passes unanimously and will be brought up at the RCPG meeting as an action item.

There was also discussion about a Ramona Community sign to be hung over the intersection of 10<sup>th</sup> and Main Street. Marvin Canton will Investigate the topic as to possibilities, funding, and procedure.

Lynn Hopewell believes it is illegal to hang a sign over state highways.

Torry states the Ramona Chamber of Commerce has information on the issue.

Dan states if we cannot place the sign at Tenth and Main, is there another alternative?

Robin states that Clean California has placed signs over state highways.

Dan brings up AB 1778 which may prevent the construction of highway and freeway lanes in certain parts of California.

All attending members agree to investigate the potential impact of AB 1778 on the SVC Project. Dan will email Subcommittee Members of his findings

The next agenda item was safety concerns at the intersection of SR 67 and Mussey Grade Road. Ramona citizen Steve Maze brought this issue to our attention last month.

Lynn Hopewell- Much of the safety concerns were alleviated when Caltrans installed a left turn center lane to assist in merging into traffic, but that safety would be improved if the intersection was repaved.

Torry Brean- The intersection needs to be resurfaced and painted, but the best solution is adding lanes and a stoplight.

Robin Maxson- The San Vicente Corridor project has identified Mussey Grade and SR 67 as a dangerous intersection. Robin suggests traffic calming measures could be effective.

It was decided that Dan inform Marvin Canton about the issue and that it be brought up during the RCPG meeting on 5/5/22.

Dan- reminds everyone that there is a SVC Stakeholders meeting tomorrow at 1:30 and that I emailed everyone with details.

Future agenda items will include the Ramona Community sign and the Mt. Woodson Trailhead sign.

A motion to adjourn was made by Lynn Hopewell and seconded by Elio. The motion passed unanimously and the meeting was adjourned at 6:51 pm
