5. ANNOUNCEMENTS

a. Caltrans Youth Bus Program and Ramona – Matt Rains shared that it came to Transportation and Trails. CalTrans decided that 18 and under can start riding the bus free until 2023. During the last Ramona Planning Group (RCPG) meeting Matt put together a letter for CalTrans. Saying we've never seen a bus. That North County Transit (NCT) goes from Escondido to Ramona and Metropolitan Transit System (MTS) that runs twice a week, two times on the same day. If you want to go to Poway, it's about a 3-hour bus ride. The letter went to the Board of Supervisors, and we haven't heard anything back. Matt said we did 3 scenarios. The Ramona Sentinel took the data Matt

provided and put in the paper, Matt can send the presentation if people want it. Matt shared that Supervisor Anderson's office asked us to do this.

7. ACTION ITEMS

a. Traffic Calming Zone 1- Community Concern



i. Community member Michele Ritchey has some concerns about the perceived increase of speed since the installation of stop signs. In addition, she is wondering where her stop sign is. (Email correspondence provided as attachment to group)

Matt said her stop sign is not on the list of stop signs. Matt asked if T&T members have questions. Dawn Perfect said not part of the original San Diego Country Estates package? Matt said no, but it seems to be a problem. Michele shared more information. Matt said there's another package in the works and that the County would come out and do another study. The County does a study before and after a project. Michele shared more information and spoke about not having sidewalks. One of the subcommittee members spoke to how they make speed adjustments and that they take 80% of the average speed. Matt went back to where they proposed the stop sign. Someone posted a sign on a light post that said, "this is not a racetrack, please slow down". Michele was calling California Highway Patrol (CHP) to patrol that area more frequently. Matt said it is CHP jurisdiction. Community member wanted to know when the heaviest traffic times are, usually in the morning and evening. Said CHP are short of officers and may not have had the ability to come out yet. Matt suggested other residents contact the CHP. Dawn suggested the County come out and do a review as well of the modified area to which Matt agreed. Dawn also mentioned that it might not be a bad idea to reach out to the elected County supervisor their elected official. Jackie shared that they talked about doing visual narrowing of road. Matt said it gives the illusion of narrowing which has a tendency to make drivers to slow down. Matt thinks we have something to take to the RCPG, the lane stripping we talked about. Can we re-access this street and ask them what we

can do. They'll come out and do a study, they're doing package two, can they include this road in that package. How long does the study take? Matt said the The engineers were very open to the fact that stop signs are not a speed deterrent. Matt mentioned that they have the unintended side effect. Matt will ask the County to come out and re-access the area. Put it on the County's radar. Matt said the last email he sent to us also went to the person one step above who he'd been talking to at the County. Someone suggested reaching out to Supervisor Joel Anderson. Matt said it might make a difference reaching out to Supervisor Anderson.

Motion made by Dawn Perfect to have the County come out and review stop sign changes made and present data, 2nd by Jackie Sadler. 4-0-0-4 (Ken Brennecke, Casey Lynch, Robin Joy Maxson and Richard Tomlinson absent).
