- 7. Rancho de Canada: Canada de San Vicente Ecological Reserve; public access: Glenn Morgan (Ramona Trails Assoc) provided a brief history of the property, formerly known as Monte Vista Ranch. It features 20+ miles of trails traversing the 5000 ac ranch (near Barnett Ranch). Many years ago, there was a 36 lot housing development planned, along with public access trails and a conference center. The county did not approve the plan, and the ranch was sold a couple of times. It is now owned by CA Fish & Wildlife. There is interest in regaining public access to the existing trails, however the state has refused, and has refused to provide any information about the ranch, including budget documents, even after formal public records request was made. Ramona Trails Association is contacting public officials to discuss the issues. Anyone interested in helping should contact Glenn Morgan/Ramona Trails Assoc.
- 8. Mussey Grade Road/Hwy 67 alignment. Very brief discussion of some options for improvement, including Dye Street as an option. The RCOG reported there will be a meeting to discuss early 2025.
