4. Corrections/Approval to the Minutes-motion to approve minutes of 8-25-14 by Bob H., second by Scott E. VOTE: 5-0 Minutes from 3-24-14 still unaccounted for; Cheryl W. to contact Karen Carlson to retrieve notes.

7. Information Received from County on Inquiry of Flooding at Residence on Arena Way-  
Kristie Mansolf read a report from DPW reviewing drainage on Arena Way. DPW has agreed that there is more need for underground drainage in this area but regrets to notify us that this work is too large for the DPW to handle at this time. County requested to work with DPW Capital Improvement Projects to resolve this issue. Jim Cooper visited the site and has concerns of how new drains are going to fix the issue because most houses on the street are lower than the street level. Mr Cooper requested address of proponent so he could visit the site for further review.
8. Consideration of Information Received from the County Regarding the Pathway on Ramona St. by Warnock/Ramona St. Solar Facility-Carl Hickman read from documents from the County and noted that there seems to be a bit of confusion in the wording regarding the email chain from the County. The confusion is regarding the pathway along Warnock and Ramona St. Jim Cooper read from the Negative Declaration document on page 17 dated May 3, 2012. The reading stated "the applicant shall improve to the satisfaction to the Dept of Parks and Recreation and/or the Dept of Public Works a pathway to a width of 10' as indicated on the plot plan". Kristie Mansolf mention that she believes the pathway was not shown on plot plan, there was no proof available. Jim Cooper continued to read "upon acceptance of the pathway improvement all financial security (if any) for the improvements of the pathway facility shall be released". Carl Hickman noted that (the above mentioned reading) is some of the confusion regarding the pathways. Scott Ensign reports that he has walked the Warnock and Ramona St pathways and approximately 1500' of the Warnock pathway has been cleared. Residents noted seeing County truck with clean-up crew. Motion to send the RCPG a letter to Diane Jacobs re: the disregard of pathway requirements and conditions;
