7. Discussion regarding the San Diego County Traffic Advisory Committee about a 4 way stop at 5<sup>th</sup> St and D St. Points made were:
  - a 4 way would be consistent with the other intersections along D St.
  - but only 2 issues/incidents have occurred in the past 5 years; one incident had injuries. The details of the accidents are not known.
  - leaving as a 2 way allows traffic to flow. However, it was pointed out that the 2 way stop in on D St, thus the flow on D St would not change with a stop sign on 5<sup>th</sup> St.
  - there is to enough compelling reason to change things now.Motion: There is not enough compelling evidence to change the 2 way to a 4 way stop; keep the status quo at the intersection of 5<sup>th</sup> St and D St.

8. County (DPW) Multi-year resurfacing program: Jim Cooper updated the committee on this. Found a number of our recommendations have not been included in the program. A request was submitted to the county about our list. County will keep RCPG advised. We have not allowed things to fall through the cracks and will keep on this. The summer will likely bring another request from the county. This current list is posted on the DPW website as to where the resurfacing will be occurring around the county. Jim recommends no additional action at this time.
